SURFACE PREPARATION

Remove any loose or flaking material from the surface to be primed. Surfaces must be clean, dry and free from grease, dust and dirt. Glossy or heavily sealed surfaces must be sanded prior to painting. Lightly sand wood or pvc prior to application. (N.B. Avoid the inhalation of dust. Wear a suitable dust mask if dry sanding and take special precautions when sanding pre-1960's oil based paint surfaces as they may contain harmful lead). On metal remove any rust and clean with an alcohol based cleaner. Clean galvanised surfaces with methylated spirit. Allow the surface to dry fully before application.

APPLICATION

Stir thoroughly before use. Suitable for brush or roller application. Two full coats of waterbased primer should be applied to give the optimum surface preparation.
