**SURFACE PREPARATION** Surfaces to be painted must be clean, dry and free from grease, dust and dirt. Bare, untreated timber should be treated with a suitable preservative, previously painted timber should be sanded prior to painting. Avoid the inhalation of dust. Wear a suitable dust mask if dry sanding and take special precautions when sanding pre-1920s oil based paint surfaces as they may contain harmful lead. Timber or masonry with fungal growth should be treated with a proprietary fungicide prior to application. Ensure any landscaped or cross-slatted timber is allowed to thoroughly weather before applying. Treat any knots with an appropriate knotting solution. Masonry should be clean, dry and sound prior to painting.

If the masonry is powdery it should first be treated with a masonry primer. Previously painted metal should be lightly sanded prior to painting. Bare metal should be primed with a suitable metal primer. **APPLICATION** Stir thoroughly before use. Do not apply in rain or if rain is likely before the paint can fully dry. Apply using a brush. Apply liberally along the grain of the wood. Two full coats of exterior eggshell should be applied to give the desired colour and ensure good resistance to weathering. Additional coats may be required on bare timber or where a large colour change is required. Coverage approximately 25m<sup>2</sup> per 2.5L on depending on the nature of the surface being painted. Average drying time 2 hours. Allow 5 hours between coats. Hard Dry in 24 hours. Do not apply in temperatures below 10°C.

**PRECAUTIONS** This product is not suitable for decking. Do not apply in frost conditions.

**CLEANING** After removing as much paint as possible, wash brushes immediately in cool water. Replace lid firmly after use. **STORAGE** This product is water based and so must be protected from frost and extreme temperatures.
