**Victoria cake:** icing sugar, natural yoghurt [MILK], flour [WHEAT flour (WHEAT flour, calcium carbonate, niacin, iron, thiamine)], sugar, whole EGG [free range EGG-pasteurised], butter (MILK), rapeseed oil, strawberry puree [strawberry, sugar, natural flavouring, purple carrot concentrate juice], sweetened condensed milk (MILK, sugar), freeze dried strawberry, white chocolate crispearls [white chocolate (sugar, cocoa butter, whole MILK powder, whey powder (MILK), emulsifier: SOYA lecithin, natural vanilla flavouring), crisped cereals (WHEAT flour, sugar, WHEAT malt flour, starch (WHEAT), raising agent (sodium bicarbonate), salt, cocoa butter, natural vanilla flavouring), glucose syrup, sugar, glazing agent (gum arabic)], baking powder [raising agents: disodium diphosphate, sodium hydrogen carbonate; carrier: WHEAT flour], whole MILK powder (whole MILK, lactose), water, rice vinegar, strawberry powder, pectin powder, pectin powder, glucose syrup, glycerine, vanilla pods: vanilla beans, citric acid.
