

Water Based



PREPARATION AND APPLICATION

The surface to be painted should be stable, firm, dry and free of dust, sand, loose old paint, dirt, grease and oil. This paint is self-priming.

Application



For use on bare surfaces, thin the product up to 15% using clean water.

Stir thoroughly before each use.

Suitable for application by brush, roller or spray. If necessary thin paint using water. Ensure good ventilation during application and drying.

Coverage



Allow 4 hours for each coat to dry before applying additional coats.

Drying Time



Remove as much product as possible from application tool when finished painting, then clean in warm, soapy water and rinse thoroughly.

Do not release large quantities into drains or watercourses. Dispose of contents/container to comply with local regulations. Metal tin may be recycled.

Recoat Time



STORAGE AND TRANSPORTATION

To avoid the risk of spillage, always store and transport in a secure and upright position. Protect from frost and extreme temperatures. Use within 12 months of purchase.

If using a spray machine, do not breathe spray or mist. Avoid contact with skin and eyes. In the event of contact with eyes, rinse immediately with water and seek medical advice. If medical advice is needed, have paint tin or label at hand.
